## Membership category & Fees Structure for 2022-23

- 1) **Rental Member** : Any Individual, Company, Limited Liability Partnership, Partnership Firm which is registered with proper authority, whose Main / Core business is to provide services of AWP on rental basis is eligible for membership as Rental Member as the board may deem fit.

**Fees as mentioned below:**

- 2) **Dealer Member** : Any Individual, Company, Limited Liability Partnership, Partnership Firm which is registered with proper authority, who is a INDIA registered dealer of any parts or machines related to AWP is eligible for membership as Dealer Member as the board may deem fit.

Any Applicant members whose CORE business is that of a dealer and has a few machines on rental basis, is eligible in only this category.

**Fees as mentioned below:**

(a) Admission Fees (one time) : 25,000 (b) Annual Subscription : 25,000

\*Members in this category do not have VOTING rights

- 3) **Foreign Member** : Any Individual, Company, Limited Liability Partnership, Partnership Firm which is registered with proper authority and having registered address outside of INDIA is eligible for membership as Foreign Member as the board may deem fit.

Any India representative office for any Multi-National Company shall also be eligible in this category only

**Fees as mentioned below:**

(a) Admission Fees (one time) : 50,000 (b) Annual Subscription : 50,000

- 4) **Local Manufacturer Member** : Any Individual, Company, Limited Liability Partnership, Partnership Firm which is registered with proper authority who is a INDIA registered manufacturer of any parts or machines related to AWP is eligible for membership as Local Manufacturer Member as the board may deem fit.

Any Applicant member, whose CORE business is that of a manufacturing and has a few machines on rental basis, will have to apply in this category

Any Indian Manufacturer having offices / representative office outside of India, shall be eligible as a Foreign Member.

**Fees as mentioned below:**

(a) Admission Fees (one time) : 50,000 (b) Annual Subscription : 50,000

- 5) **Associate Member** : Any Individual, Company, Limited Liability Partnership, Partnership Firm which is registered with proper authority who is not eligible in any of the above mentioned category, is related to the AWP industry is eligible for membership as Associate Member as the board may deem fit

**Fees as mentioned below:**

(a) Admission Fees (one time) : 25,000 . (b) Annual Subscription : 25,000

\*Please note if a member deals in both the Category i.e Rental as well as Dealer then they have to pay the fees whichever is higher.

**For Example:**

- (I) If a member has 40 machines for rental and also falls under dealer category so they have to pay Rs. 25,000 (+GST).
- (ii) If a member has 55 machines for rental and also falls under dealer category so they have to pay Rs. 50,000 (+GST).
